John Viets was appointed guardian, 18 May 1818, of Esther and Eliza Remington, the latter about 18 years old.* The estate was distributed, 4 July 1818, by Abijah Remington, and Abijah and Samuel Hastings, between ROSANNA Weaver, widow of the deceased, and Esther and Eliza Remington, land and widow's thirds.
