

Daughter Florence—wife—brother Henry and said wife, ex'or and ext'x. Proved 30 Oct. 1691 by Florence Mompesson, the relict, power reserved to Henry Mompesson. On 1 Sept. 1710 adm'on of goods, etc., unadministered by Florence Mompesson, the relict, now dec^d, granted to Eleanor Newman alias Mompesson (wife of Francis Holles Newman, Esq.), the daughter and next of kin, Henry Mompesson, the brother, etc., being dead. (170 Vere.)

22 Feb. 1698-9. Roger Cossins of Crewkerne, co. Somerset, gent. "Geo. Bisse" a witness. Proved 22 April 1699. (55 Pett.)

26 April 1699. Anthony Plimpton, the elder, of Croscombe, co. Somerset, gent. Niece Susanna Davis—cousin Thomas Pew of Shepton Mallett and Ann his wife—kinswoman Mary Abbott of Shepton Mallett—cousin Thomas Pew's son Thomas and daughter Gertrude—niece Mary Plimpton (now Walter) of Croscombe—cousin William Bisse of Blandford—cousin Robert Plimpton of London and his son Anthony—cousin Elizabeth Plimpton, daughter of nephew William Plimpton, late of London, dec^d—cousin Elizabeth Wells (now Salway) of Cresham and her sons Edward and John—cousin Ann Oborn—cousin Thomas Bisse, late of Quantockhead, and cousin Diana Shint, wife of William Shint—cousin William Berkenhead and his four children—cousin Richard Clark of Shepton Mallett, and his sister Ann Clark—cousin Richard Plimpton—cousin Anthony Plimpton, jun^r, of Croscombe, mercer, ex'or. Proved 12 Sept. 1699 by said ex'or. (149 Pett.)

16 Nov. 1709. Richard Morgan, the elder, of Easton in Gordane alias St. George's, co. Somerset, but now of the city of Bristol, Esq. Eldest son Richard Morgan and his wife—daughter Anne, unmarried—eldest daughter Joanna, the now wife of Edward Bisse of the said par. of St. George, clerk—youngest son Thomas Morgan—to George Freeman of the city of Bristol, gent. Proved 9 Dec. 1709 by Richard Morgan, Esq., the son. (292 Lane.)

19 Nov. 1715. Henry Mompesson of Babington, co. Somerset, Esq. "To Thomas and George the sons of Captain Bisse five Pounds apiece"—"to my kinsman M^r Bisse that was a souldier at Gibraltar" £20—wife Elizabeth. Proved 13 Feb. 1715-6 by Elizabeth, the relict. (31 Fox.)

15 Jan. 1716. John Covant of Portbury, co. Somerset, gent. Kinsman John Biss of the Island of Madeira, merchant—wife Mary—Edward Biss, Joanna Biss, and Irania Biss, son and daughters of kinsman Edward Biss of St. George's, clerk—said wife and kinsman John Biss, ext'x and ex'or. Proved 27 April 1727 by said Mary, power reserved to said John. (84 Farrant.)

29 April 1735. Thomas George of Croscombe, co. Somerset, clothier. Testator had conveyed all his real estate to John Bisse, clerk, Rector of Weston super Mare in same co., and John Rogers of Dinder in said co., gent., in trust—wife Catherine—niece Elizabeth Bryant—nephew George Bryant—nephews Thomas Speed and John Speed. Elias Rebotier a witness. Proved 23 June 1741 by Catherine, the relict. (153 Spurway.)
