- 1492 V. John, b. June 22, 1817, at Preakness; m. Eleanor (b. Nov. 27, 1823, dau. of John) Ackerman, of New Bridge, Nov. 19, 1840; d. March 1, 1887. He kept a grocery store for several years in Commerce street, New York; was afterwards in the milk business, in Williamsburgh, then removed to New Bridge, and finally to Paterson. The will of John R. Doremus, of Paterson, dated June 27, 1873, was proved March 25, 1887.<sup>1</sup>
- 1493 VI. George, m. 1st, Elizabeth Terhune; 2d, Ida S., dau. of Samuel Harris, Dec. 29, 1859. He bought the farm of Peter J. Doremus, at Red Mills, and lived there several years. He afterwards removed to River Edge.
- 1494 VII. Christina, m. 1st, Cornelius Van Buskirk; 2d, Henry Van Buskirk. She lives at Demarest. Issue: 1. Jacob; 2. Abraham; 3. Richard, m. Jennie, dau. of John Demarest, of Cresskill; 4. Augustus. Richard is the only survivor of these four sons; he lives at Schraalenburgh. Children: 1. Henry; 2. Edward; 3. Christina; 4. Nellie; 5. Taylor.
